## RESOLUTION NO. R20-94

**A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO APPROVE AND DIRECT PAYMENT OF THE SUM OF \$70,509.02 TO BUTLER COUNTY, OHIO, TO REIMBURSE THE COUNTY FOR THE COSTS OF LABOR AND EQUIPMENT PROVIDED TO THE CITY FOLLOWING THE 2019 MEMORIAL DAY TORNADOES.**

**WHEREAS**, devastating tornadoes struck the City of Trotwood on Memorial Day in 2019; and

**WHEREAS**, a number of cities, villages, townships and/or counties provided valuable assistance and aid to the City in response to this disaster; and

**WHEREAS**, the City of Trotwood entered into mutual aid agreements with various cities, villages, townships, and/or counties, which agreements required reimbursement to these public agencies for the services provided in the event Federal Emergency Management Agency (FEMA) funds were subsequently received by the City in response to the disaster; and

**WHEREAS**, the FEMA approved the payment of federal and non-federal funds to the City of Trotwood/mutual aid for debris removal and supplies for Project #118081 in relation to the Memorial Day 2019 tornado damage (Disaster #4447DR).

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** City Council hereby authorizes the City Manager to approve and direct payment of the sum of \$70,509.02 to Butler County, Ohio, to reimburse the county for the costs of labor and equipment provided to the City following the 2019 Memorial Day tornadoes.

**SECTION II:** This Resolution shall take effect and be in full force from and after the date of its passage.
