

**RESOLUTION NO. R20-85****A RESOLUTION BY THE TROTWOOD CITY COUNCIL TO CERTIFY DELINQUENT WATER, SEWER, TRASH, AND STORM DRAINAGE BILLS TO THE AUDITOR OF MONTGOMERY COUNTY, OHIO, FOR PLACEMENT ON THE TAX DUPLICATE.**

**WHEREAS**, certain property owners in the City of Trotwood, Ohio, have delinquent water, sewer, trash, and storm drainage bills and all attempts to collect these outstanding amounts have been unsuccessful; and

**WHEREAS**, pursuant to the City of Trotwood Codified Ordinances, Chapters 921, 923, 927, and 929, it is necessary to collect these delinquent water, sewer, trash, and storm drainage bills by certifying these amounts, together with any interest and penalties allowed by law, to the Montgomery County Auditor for placement on the property tax duplicate; and

**WHEREAS**, a list of the delinquent accounts and the unpaid amounts is attached hereto and incorporated herein as Exhibit "A"; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I.**

The Finance Director is hereby authorized to assess delinquent charges against the property of City of Trotwood property owners who have delinquent water, sewer, trash, and/or storm drainage bills, together with any interest and penalties allowed by law.

**SECTION II.**

The parcel identification numbers of the property owners with delinquent water, sewer, trash, and/or storm drainage bills are set forth in the document attached hereto and incorporated herein as Exhibit "A", as is the total amount of the charges being certified to the Montgomery County Auditor.

**SECTION III.**

This Resolution, together with Exhibit "A" attached hereto and incorporated herein by reference, shall be certified by the Clerk of Council to the Auditor of Montgomery County, Ohio, to be placed on the tax duplicate and collected as other taxes are collected according to law.

**SECTION IV.**

Payments received at the City of Trotwood prior to September 13, 2020, will not be certified to the Montgomery County Auditor and shall be removed from the list.
