RESOLUTION NO. R20-83

A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH RUMPKE WASTE AND RECYCLING FOR REFUSE COLLECTION, RECYCLING, AND DISPOSAL SERVICES FOR A PERIOD OF THREE (3) YEARS, COMMENCING ON OCTOBER 1, 2020 AND ENDING ON SEPTEMBER 30, 2023, WITH THE OPTION TO EXTEND THE TERM OF THE CONTRACT FOR THREE (3) ADDITIONAL ONE-YEAR TERMS.

WHEREAS, the City of Trotwood, Ohio, published a Notice to Bid for refuse collection and disposal services in a newspaper of general circulation as required by law; and

WHEREAS, the City received one (1) sealed bid from Rumpke Waste and Recycling; and

WHEREAS, the Finance Director and the City Manager recommend the City enter into a contract with Rumpke Waste and Recycling for refuse collection, recycling, and disposal services for a period of three (3) years commencing on October 1, 2020 and ending on September 30, 2023, with the option to extend the term of the contract for three (3) additional one-year periods.

Agreement with Rumpke Waste and Recycling Services for refuse collection, recycling, and disposal services for a period of three (3) years, commencing on October 1, 2020 and ending September 30, 2023, with the option to extend the term of the contract for three (3) additional one-year

periods.
