A RESOLUTION BY THE TROTWOOD CITY COUNCIL AUTHORIZING THE CITY MANAGER TO ACCEPT A GRANT THROUGH THE FISCAL YEAR (FY) 2019 ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM FROM THE DEPARTMENT OF HOMELAND SECURITY FOR THE PURPOSE OF REPLACING FIRE HOSES, NOZZLES AND ADAPTERS.

**WHEREAS,** the City of Trotwood, Ohio, has been awarded a grant through the FY 2019 Assistance to Firefighters Grant Program from the Department of Homeland Security in the amount of \$166,463.64 for the purpose of purchasing fire hoses, nozzles, and adapters; and

WHEREAS, the City is required to contribute funding in an amount equal to or greater than 10% of the federal grant fund awarded, which represents a contribution of no less than \$16,646.36 from the City, for a total projected budget of \$183,110.00; and

**WHEREAS,** the City Manager recommends that the Trotwood City Council authorize the City Manager to accept the grant funds from the Department of Homeland Security.
