

RESOLUTION NO. R20-80

A RESOLUTION BY THE TROTWOOD CITY COUNCIL GRANTING APPROVAL OF THE EMERGENCY WATERSHED PROJECT, PROJECT #39-10-19-5077-402 (WOLF CREEK STREAM TRIBUTARY, STORM DEBRIS REMOVAL), AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH THE UNITED STATES DEPARTMENT OF AGRICULTURE’S NATURAL RESOURCES CONSERVATION SERVICE TO SECURE FUNDING AND COMPLETION OF THE PROJECT.

WHEREAS, devastating tornadoes struck the City of Trotwood, Ohio, on Memorial Day of 2019, which caused severe damage, storm debris, and power outages in the City and surrounding areas; and

WHEREAS, the Cities of Trotwood and Clayton were recently informed of grant approval by the United States Department of Agriculture’s Natural Resources Conservation Service (“USDA-NRCS”) for the Emergency Watershed Project (“EWP”), Project #39-10-19-5077-402 (Wolf Creek Stream Tributary, Storm Debris Removal), for the removal of trees and other storm debris caused by the Memorial Day 2019 tornadoes; and

WHEREAS, the City Manager and the Public Works Operations Supervisor have recommended that City Council authorize the City Manager to sign any necessary agreements and take any additional action required by the USDA-NRCS to proceed with the aforementioned grant award to secure the funding for the work to be completed with respect to the EWP, Project #39-10-19-5077-402 (Wolf Creek Stream Tributary, Storm Debris Removal).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: City Council hereby grants approval of the EWP, Project #39-10-19-5077-402 (Wolf Creek Stream Tributary, Storm Debris Removal), and authorizes the City Manager to enter into any necessary agreements and to take any additional action required to secure the funding for the work to be completed with respect to this EWP.

SECTION II: This Resolution shall take effect and be in full force from and after the date of its passage.
