**SECTION I:**

The Trotwood City Council determines that the Outdoor Holiday Light Contest is a city-sponsored event intended to serve the public purpose of beautifying the city, spread holiday cheer and goodwill, and maintain strong community relations.

The Trotwood City Council hereby authorizes expenditures not to exceed \$300.00 for cash prizes to the winners of the Annual Trotwood Outdoor Holiday Light Contest in the following amounts:

Second Place	\$100.00
Third Place	\$ 50.00
