

RESOLUTION NO. R21-40**A RESOLUTION BY THE TROTWOOD CITY COUNCIL TO CERTIFY DELINQUENT CHARGES FOR WATER, SEWER, TRASH AND/OR STORM DRAINAGE TO THE AUDITOR OF MONTGOMERY COUNTY, OHIO, FOR PLACEMENT ON THE TAX DUPLICATE.**

WHEREAS, owners of certain parcels of property situated in the City of Trotwood, Ohio, have unpaid water, sewer, trash and/or storm drainage bills and all attempts to collect these outstanding charges have been unsuccessful; and

WHEREAS, a list of the charges owed by owners of certain parcels of property set forth in the document attached hereto and incorporated herein as Exhibit "A" are past due and now delinquent; and

WHEREAS, in accordance with the City of Trotwood Codified Ordinances, Chapters 921, 923, 927, and 929, it is necessary to collect these unpaid water, sewer, trash and/or storm drainage bills by certifying the delinquent charges, together with any interest and penalties allowed by law, to the Montgomery County Auditor for placement on the tax duplicate.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The City Manager or his designee is hereby authorized to certify delinquent charges owed to the City of Trotwood against parcels of property situated in the City of Trotwood for unpaid water, sewer, trash and/or storm drainage bills, together with any interest and penalties allowed by law, in the total amount of Five Hundred Seventy-One Thousand, Eight Hundred Twenty-Nine Dollars and Seventy-Two Cents (\$571,829.72), for placement on the tax duplicate.

SECTION II:

The parcel identification numbers of the properties with delinquent charges described herein are set forth in the document attached hereto and incorporated herein as Exhibit "A", as is the total amount being certified to the Montgomery County Auditor.

SECTION III:

A copy of this Resolution, together with Exhibit "A" attached hereto and incorporated herein, shall be certified by the Clerk of Council to the Auditor of Montgomery County, Ohio, to be placed on the tax duplicate and collected as other taxes are collected according to law.

SECTION IV:

This Resolution shall take effect and be in force from and after the date of its passage.
