

**RESOLUTION NO. R21-41****A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
APPOINTING ANGELA COE TO THE BOARD OF ZONING  
APPEALS FOR THE CITY OF TROTWOOD, OHIO, FOR THE  
REMAINDER OF THE UNEXPIRED TERM OF FORMER  
BOARD OF ZONING APPEALS MEMBER LOWELL RIEGEL.**

**WHEREAS**, the City Charter established a Board of Zoning Appeals consisting of five (5) qualified electors of the Municipality appointed by the majority vote of Council; and

**WHEREAS**, the Council has an obligation to appoint members to such Board for a five (5) year term, without compensation, and subject to obligations, powers, and duties as set forth in the Charter and the Trotwood Codified Ordinances; and

**WHEREAS**, by prior legislation, Resolution R18-116, Mr. Lowell Riegel was appointed to serve on the Board of Zoning Appeals for a five-year term commencing January 1, 2019 and ending December 31, 2023; and

**WHEREAS**, Mr. Lowell Riegel passed away on October 4, 2020; therefore, City Council must appoint a qualified elector of the City of Trotwood to serve on the Board of Zoning Appeals for the remainder of the unexpired term of Mr. Lowell Riegel.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** City Council respectfully acknowledges Mr. Lowell Riegel passed away on October 4, 2020.

**SECTION II:** Angela Coe, a qualified elector of the City of Trotwood, Ohio, is hereby appointed to serve as a member of the Board of Zoning Appeals for the remainder of the unexpired term of Mr. Lowell Riegel. Accordingly, Ms. Coe shall serve on the Board of Zoning Appeals beginning September 7, 2021 and ending December 31, 2023.

**SECTION III:** Ms. Coe shall be administered her Oath of Office at such time that is mutually convenient for said elector and the Mayor.

**SECTION IV:** This Resolution shall take effect and be in force from and after the date of its passage.
