WHEREAS, the obsolete and/or surplus equipment is fully set forth in the document attached hereto and incorporated herein as Exhibit "A"; and

WHEREAS, the City Manager recommends that Council declare the items surplus and authorize the items set forth in the attached Exhibit A to be sold at public auction and/or otherwise disposed of.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

Trotwood City Council hereby finds that the property listed in Exhibit "A", which is attached hereto and incorporated herein by reference, is obsolete and/or surplus, dilapidated and in non-functioning order, and no longer needed for any public purpose.
