

**RESOLUTION NO. R21-38****A RESOLUTION BY THE TROTWOOD CITY COUNCIL  
AUTHORIZING THE CITY MANAGER TO DECLARE CERTAIN  
OBSOLETE AND/OR SURPLUS FIRE AND EMS EQUIPMENT  
AS NO LONGER NEEDED FOR A PUBLIC PURPOSE AND  
AUTHORIZING SAID EQUIPMENT TO BE SOLD AT PUBLIC  
AUCTION AND/OR OTHERWISE DISPOSED OF.**

**WHEREAS**, the Fire Department Chief has determined that certain equipment of the Trotwood Fire Department can no longer be utilized because the equipment is no longer safe and/or serviceable and the cost to restore the equipment to a safe and/or serviceable condition exceeds the value of the property; and

**WHEREAS**, the City Manager agrees that certain equipment belonging to the City are obsolete and/or surplus, dilapidated and in non-functioning order, and no longer needed for any public purpose; and

**WHEREAS**, the Fire Department Chief has requested these obsolete and/or surplus items be sold at public auction and/or otherwise disposed of; and

**WHEREAS**, the obsolete and/or surplus equipment is fully set forth in the document attached hereto and incorporated herein as Exhibit "A"; and

**WHEREAS**, the City Manager recommends that Council declare the items surplus and authorize the items set forth in the attached Exhibit A to be sold at public auction and/or otherwise disposed of.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE  
CITY OF TROTWOOD, STATE OF OHIO:**

**SECTION I:** Trotwood City Council hereby finds that the property listed in Exhibit "A", which is attached hereto and incorporated herein by reference, is obsolete and/or surplus, dilapidated and in non-functioning order, and no longer needed for any public purpose.

**SECTION II:** The City Manager is hereby authorized to have the equipment listed in the attached Exhibit A sold at public auction and/or otherwise disposed of.

**SECTION III:** This Resolution shall take effect and be in full force from and after the date of its passage.
