

RESOLUTION NO. R21-36

A RESOLUTION BY THE TROTWOOD CITY COUNCIL ACCEPTING THE BID OF L.J. DEWEESE CO., INC. FOR THE TROTWOOD CATCH BASINS PROJECT, WHICH RELATES TO THE REMOVAL AND REPLACEMENT OF IDENTIFIED CURBS AND CATCH BASINS WITHIN THE CITY OF TROTWOOD, OHIO, AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT WITH SAID CONTRACTOR TO COMPLETE THE PROJECT FOR AN AMOUNT NOT TO EXCEED \$317,630.50, WHICH IS THE CONTRACT PRICE OF \$288,755.00, PLUS A CONTINGENCY AMOUNT EQUAL TO 10% OF THE TOTAL CONTRACT PRICE, OR \$28,875.50.

WHEREAS, the City has identified certain curbs and catch basins that need removed and replaced within the City of Trotwood, Ohio; and

WHEREAS, the City advertised the Trotwood Catch Basins Project (the "Project") on June 8, 2021 and June 15, 2021 as required by law, and the bid of L.J. DeWeese Co., Inc. was determined to be the lowest and best bid submitted; and

WHEREAS, the City Manager and the Public Works Project Manager recommend that City Council authorize the City Manager to enter into an agreement with L.J. DeWeese Co., Inc. to complete the work necessary for this Project for an amount not to exceed \$317,630.50, which is the bid contract price of \$288,755.00, plus a contingency amount equal to 10% of the total contract price, or \$28,875.50.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I: The City of Trotwood solicited for bids for the Trotwood Catch Basins Project for the removal and replacement of certain curbs and catch basins in the City of Trotwood as required by law on June 8, 2021 and June 15, 2021.

SECTION II: The bids were reviewed and the City Manager and the Public Works Project Manager recommend that City Council accept the bid of L.J. DeWeese Co., Inc. for the Trotwood Catch Basins Project.

SECTION III: City Council finds that the bid of L.J. DeWeese Co., Inc. was the lowest and best bid submitted and, therefore, accepts the same.

SECTION IV:

City Council authorizes the City Manager to enter into an agreement with L.J. DeWeese Co., Inc. to complete the work necessary for the Trotwood Catch Basins Project for a contract price of \$288,755.00, plus a contingency amount equal to 10% of the total contract price, or \$28,875.50.

SECTION V:

This Resolution shall take effect and be in full force from and after the date of its passage.
