ORDINANCE NO. OR22-21

AN ORDINANCE BY THE TROTWOOD CITY COUNCIL APPROVING THE CURRENT REPLACEMENT PAGES TO THE CITY OF TROTWOOD CODES OF ORDINANCES.

WHEREAS, certain provisions within the City of Trotwood Codes of Ordinances ("Codified Ordinances") should be amended to conform with current state law as required by the Ohio Constitution; and

WHEREAS, various ordinances of a general and permanent nature that have been passed by the Trotwood City Council should be included in the Codified Ordinances; and

WHEREAS, the City has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revisions.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF TROTWOOD, STATE OF OHIO:

SECTION I:

The ordinances of the City of Trotwood, Ohio, of a general and permanent nature, as revised, recodified, rearranged, and consolidated into component codes, titles, chapters, and sections within the 2021 Replacement Pages to the City of Trotwood Codes of Ordinances are hereby approved and adopted.

SECTION II:

The chapters and sections attached hereto and incorporated herein as Exhibit "A" are hereby added, amended, or repealed as respectively indicated in order to comply with current state law regarding the codification of local ordinances.

SECTION III:

The complete text of the sections of the Codified Ordinances referenced in Exhibit "A", which is attached hereto and incorporated herein, is set forth in full in the current replacement pages to the Codified Ordinances. Any summary publication of this Ordinance shall include a complete listing of these sections. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.
